**COMMENTS:** Prohibits a financial institution or bank from charging a fee to cash a check which is written on an account from that financial institution or bank.

**SYNOPSIS:** Deferred presentment services, payday loans, consumer authorized to rescind loan transaction, rollover loans, extended payment plans, deferred presentment services transaction prohibited for military personnel, rebate upon prepayment, certain activities prohibited, Secs. 5-18A-12, 5-18A-13 am'd.

**LAST ACTION:** Pending committee action in house of origin – 03--27-08

**CURRENT STATUS:** -In committee – Banking & Insurance

**COMMENTS:** Allows for a 24 hour right to rescind, prohibits rollover transactions, allows for an extended payment plan, restricts transactions to military personnel and their dependents, provides for a rebate of fees in the event of prepayment, and prohibits certain activities.
